- 1. "PMI Confidential Information" for purpose of this Agreement means information, knowledge, trade secrets or other data, as set forth more fully in paragraph 2, which is not a matter of public record or otherwise available to the public at large or to the project management profession from sources other than PMI and which PMI has not yet determined to make available publicly.
- 2. "Information" for purposes of this Agreement includes all data, trade secrets, membership lists, knowledge, facts, processes, and procedures, regardless of the form in which it is maintained or transmitted, including but not limited to written documents, compact disks, audio tapes, handwritten notes, electronically stored data, computer disks, as well as verbal, telephonic and email communications.
- 3. I agree that I will not disclose any PMI LAKESHORE Chapter Confidential Information obtained by me as a result of my participation in the above-referenced Activity to any person, organization or group except (a) to persons authorized by PMI Lakeshore Chapter to receive such information, including other members of the Activity and persons who have a need to know the information in order to conduct the business of PMI Lakeshore Chapter and (b) by means of communications made in a manner so as to protect the PMI Lakeshore Chapter Confidential Information from disclosure to unauthorized persons.
- 4. I agree that this Agreement is to be deemed performed in and governed by the laws of the Province of Ontario and that any judicial action resulting from a dispute relating to this Agreement shall be brought only in a court of the Province of Ontario or in the Federal Court of Canada to which I consent to personal jurisdiction.
- 5. This Agreement expresses my complete understanding as to the subject matter hereof. I understand that its terms may not be varied, amended or changed without the express written consent of PMI LAKESHORE Chapter, by its authorized representative, and that the failure of PMI Lakeshore Chapter to enforce any provision hereof does not constitute a waiver by PMI Lakeshore Chapter of that provision or any other provision of this Agreement.
- 6. In the event of a breach of this Agreement I recognize that PMI Lakeshore Chapter does not have an adequate remedy at law. Additionally, I agree that I will not collaborate with other board members to malign PMI Lakeshore Chapter.
